

Innovative volunteers create long-lasting solutions

One of the most powerful advantages of our volunteering approach is that when you unlock the power of people, volunteers will constantly surprise you with the most amazing innovations to make long-lasting change possible.

For example, in Rwanda – like so many countries around the world – people with disabilities face huge barriers accessing the quality healthcare and health information they need. This means that they are more vulnerable to sexual violence and sexually transmitted diseases.

Local VSO volunteer Brown Niyosaba, who is deaf herself, is helping others access the support they need. She has taught 80 students about vital sexual and reproductive health issues and also supervises a team of instructors to train community health workers and nurses in Rwandan Sign Language. Her dream is to empower all deaf people like her to have an equal chance of expressing their ideas, growing as individuals and contributing to Rwanda's development. And the beauty of her work is that this unique approach can be adopted and adapted in other countries, creating a ripple of positive change for people with disabilities around the world.

Why should I write a Will?

By making a Will, you ensure your wishes are carried out, and the people and causes you care about are looked after.

How can I make my Will?

A Will is a legal document and so, for peace of mind, we always recommend that you ask a solicitor to draw it up for you. We offer a Free Wills Service. To find out more please visit our website.

How often can I change my Will?

You can make and change your Will as often as you like, and we recommend changing your Will

any time your circumstances change. For example, if you get married, or have a new grandchild.

What information should I include to remember VSO in my Will?

You would need to include our full registered name, which is VSO, and our registered charity number, which is 313757. You can find some suggested wording you can use by typing "VSO gift in Will" in your internet browser.


Are there any tax benefits of leaving money to a charity?

Gifts to charity are tax-free and

these gifts are not included when your estate is valued for inheritance tax purposes. If the value of your gifts to charities totals more than 10% of the estate. there are additional benefits too. We strongly recommend that you speak to a solicitor for any advice on tax issues.

Would it help VSO if I told you I've left a gift in my Will?

You don't have to tell us if you've chosen to leave a gift to VSO. However, if you do, you will get the chance to hear more about our work fighting inequality and injustice, and you'll be invited to special events.
